# **About CSS**

Chotanagpur Sanskritik Sangh(CSS)is a non-profit grass root, socio culture voluntary organization engaged in empowering women, child, person with disabilities and distress in socio-economic-cultural fronts through its various initiatives on Education, Livelihood, Environment, child protection, Health & Nutrition, Sports, Culture, research and publication and Rehabilitation. CSS is registered under the Societies Registration Act XXI of 1860.

Chotanagpur Sanskritik Sangh (CSS) was established in Ranchi district of Bihar in the year 1968, at that time, Jharkhand came under the southern Chotanagpur area of the Bihar. This was the period when HEC, Heavy Engineering Corporation Limited in Hatia area was being established. Where on one side many villages were being destroyed, due to the displacement the socio-cultural-economic problems were born.

On the other hand there were opportunities for employment and development, but the people here were not prepared educationally and technically (except for the few people) at that time, as a result local residents could not get much benefit from it.

The organization works to organize the disadvantaged sections of the society to join them in the mainstream; women's empowerment, child rights and protection, health, disability, education, skill development, working capital, development of micro-employment, research and publication are there. At present, the institution is working directly in Ranchi & Gumla districts of the state.



Project Objective 1800 women in 20 villages of Bharno block are socioeconomically empowered and are able to protect themselves from Gender-based discrimination and Violence.

CHILDLINE is a national,24-hour emergency outreach service. It is free Phone Helpline for children up to the age of 18 years in need of care and protection. The Child line number 1098 is at toll free number that is common in all cities in India.it is a project of Govt. of India(MSJE).

Activities under this project include review of the pending cases, Increasing Child line Protection Cases, Outreach strategy and review of outreach conducted, Follow up of CAB meeting, Phone testing review, Open House, orientation about Child Protection, finalization of plan for the next week, Compliance on the feedback, Special Awareness program Case intervention protocol and discussion on the feedback on MPR by CIC, Cases received during the period and possible action to solve the cases, linkages with allied sectors etc.

### Promoting Rural Girls Education

In the rural communities girls are unable to pursue higher/job based education due to very poor financial condition of family, lack of opportunity for the girl child due to less priority on the girl child ,lack of proper guidance and career counselling.

To address this problem CSS with the support of Andheri Trust under the theme of Women Empowerment is providing financial support to needy girls from very poor financial background to pursue job oriented training course. The objective behind this project is to improve the socio economic condition of the family and help the girls become self dependent women. This will indirectly reduce child/early marriages, domestic violence, exploitation.

Since 2019, 24 girls have been provided support for ANM Course. The first batch of 2019 (4 candidates) have completed their training and have received job placements. The girls say that the attitude towards them in the community has changed. People view them with a sense of respect and other girls are also getting motivated to study.

# Promoting Girl's Mandar Group

A male dominated society is often characterized by gender specific roles which become part of the norms and tradition of the society. It could be social, cultural, religious, livelihood etc.

This project is aimed at breaking those gender stereotyped roles and norms, and ensure equal participation of girls in the community.

Hence CSS came up with the idea of forming and training a professional Mandar Playing Band. The objective behind this initiative was to solve the following purposes:

- 1. Social & economic empowerment of girls
- 2. Engagement of girls in productive activity
- 3. Break the norms that Mandar Group could comprise of only men.
- 4. Reviving and popularizing Mandar playing.

A group of 12 girls and 2 boys were identified for the Mandar Playing Band.

Pre-Training and counselling sessions were held for them and they were explained the importance and purpose of the initiative.

The training was led by renowned Mandar playing professions and folk musicians namely: - Mr.Sudama Singh, Manrakhan Baraik & Janki Devi. The participants were provided meticulous training on playing Mandar which included different beats and rhythm according to different social occasions. The group was also given training on folk music and also on composing folk songs.

The training was very systematic and the 48 day long training really equipped the group members with the art of playing Mandar drum. Post training the group has been provided with Nagada and Mandar. They have already started performing locally and they are expected to get invitation from outside their village within their block and also outside. They are also engaged in regular practice.

The group will operate within a structure with well laid guidelines and by laws which have already been prepared so that they perform as a pure professional group. The revenue generated will be properly maintained and shared among the members through the rules. There will be band manager who will manage the bookings and maintain the record of revenue.

The group is being promoted on social platforms so that they can gain popularity in the locality, district, state and also the country.





# Promotion of Girls' Football Team

Participating in sports can help break-down gender stereotypes, improve girls' and women's self-esteem and contribute to the development of leadership and strategic thinking skills.

The idea behind this initiative is to break the above stereotype. "Sport has a vital role to play in promoting women's rights. It offers girls and women opportunity to assert themselves as independent individuals in patriarchal societies.

With this motive CSS formed two girls's football team under the project Preventing Child Marriage and Early Unions in the block of Bharno. Under this initiative CSS also organized football tournament between girls and boys football team to promote gender justice and breaking the gender norms.







# Promotion of Art & Handicraft

The idea behind this initiative is to empowering girls to become young entrepreneurs and increase their income. This is also an approach to promoting gender equality. By providing young girls with the necessary skills, resources, and market access, handicrafts can lead them to financial independence, social inclusion, and creative expression.

A group of 5 girls who had some knowledge and interest of art and handicraft were identified and provided a week long residential training on traditional art and handicraft. To expand their knowledge further they were provided exposure visit to traditional atrisans centre (art centre) in the Odisha.

They were trained on the following forms of art:

Post training they have already producing many handicraft materials which are already in the market.









### Community Learning Centres

The Community Learning Centres are a system of community-based learning which not just addresses to the academics of a child but advocates for their holistic development. It has been observed that enrolment in schools is being seen as an indicator of improved rural education. However, due to gaps in the education and learning system, these school-going children lack basic awareness about the world inside, outside and around them. With structured curriculum of physical, educational, socio-cultural activities on a regular basis, the CLCs inculcate the attitude of Learning within children which eventually positively impacts their parents and families and eventually the entire village. More than, academic brilliance, focus of CLCs is on personality development and overall well-being of children.

Under this initiative 7 CLCs have been formed in the following 7 villages:-

Through this 210 children from 7 villages are receiving holistic education. The village environment is improving slowly and there is a gradual increase in focus on productive and educational activities.

सिसई. छोटानागपुर सांस्कृतिक संघ ने मंगलवार को बीएन जालान कॉलेज में बाल-विवाह उन्मूलन व किशोरी सशक्तीकरण के तहत एकदिनी कार्यशाला हुई. मुख्य अतिथि बीडीओ सुनीला खलखो ने कहा कि बाल विवाह बचपन समाप्त कर देता है. बाल विवाह के शिकार किशोर-किशोरी शारीरिक व मानसिक रूप से परिपक्व नहीं होते हैं, जिसका सीधा असर न केवल दांपत्य जीवन पर, बल्कि उनके परिवार और समुदाय पर अभिशाप की तरह पड़ता है. लड़िकयों को इसका खामियाजा अधिक उठाना पड़ता है. बाल अवस्था में गर्भधारण व प्रसव से किशोरी दुर्बल हो जाती है. इसमें कइयों की मौत हो जाती है. बाल विवाह रोकने के लिए कानून होने के बाद भी जागरूकता, शिक्षा, गरीबी व कुप्रथा से प्रतिवर्ष देश में लाखों किशोर-किशोरी बाल वधु बन रही है, जिसे रोकने के लिए हम सभी को आगे आना होगा. एसआइ अंजली कुमारी ने बाल विवाह रोकने के कानूनी प्रावधान, अधिकार, पोक्सो एक्ट, जुवेनाइल एक्ट की विस्तृत जानकारी दीं. मौके पर प्रोफेसर साहू प्रकाश लाल, डॉक्टर प्रवीण भगत, सुदिप्ती कुमारी लांबा, डॉ रेखा कुमारी, सुमित कुमारी, शांति सेवइया, आकांक्षा कुमारी, शशि, पैरो कुमारी, सुनीता कुमारी, सुमित, कृति मिंज, विश्वंभर देव तिवारी मौजूद थे.
